Well Child Check Schedule:

1. Initial Check-up (1-2 days after hospital discharge)
 - Vaccines: Hepatitis B #1 if not given in the hospital
 - Check Jaundice
 - Assess feeding
2. 2 Weeks:
 - Vaccines: Hepatitis B #1 if not already given
 - Infant should be back to Birthweight
 - Go to lab to have second Newborn Screening drawn 11-14 days old
 - Start Vitamin D 400 IU daily for breastfeeding infants
3. 1 Month:
 - Vaccines: Hepatitis B #1 if not already given
 - Review newborn screening tests
4. 2 Months:
 - Vaccines: Pentacel #1 (DTaP; Polio; Hib); Hep B #2; Prevnar #1; Rotavirus #1
 - Growth and Development Assessment
5. 4 Months:
 - Vaccines: Pentacel #2 (DTaP; Polio; Hib); Prevnar #2; Rotavirus #2
 - Growth and Development Assessment
 - Start introduction between 4-6 months
6. 6 Months:
 - Vaccines: Pentacel #3 (DTaP; Polio; Hib); Hep B #3; Prevnar #3; Rotavirus #3;
 - Growth and Development Assessment
 - Start introduction of solids if not yet begun
7. 9 Months:
 - Vaccines: None (unless catch up needed)
 - Growth and Development Assessment
 - Standardized Developmental Screening (PEDS form)

8. 12 Months:
 - Vaccines: Proquad #1 (MMR and Varicella); Hepatitis A #1
 - Growth and Development Assessment
 - Labs: Lead levels and Anemia Screening
9. 15 Months:
 - Vaccines: Pentacel #4 (DTaP; Polio; Hib); Prevnar #4
 - Growth and Development Assessment
10. 18 Months:
 - Vaccines: Hep A #2
 - Growth and Development Assessment
 - Standardized Developmental Screenings (MCHAT and PEDS)
11. 2 Years
 - Vaccines: None (unless catch up needed)
 - Growth and Development Assessment
 - Standardized Developmental Screenings (MCHAT and PEDS)
 - Labs: Lead levels and Anemia Screening
12. 2.5 Years
 - Vaccines: None (unless catch up needed)
 - Growth and Development Assessment
13. 3 Years
 - Vaccines: None (unless catch up needed)
 - Growth and Development Assessment
 - Vision and Hearing Screening (if able to cooperate)
14. 4 Years
 - Vaccines: Proquad #2 (MMR and Varicella); DTaP #5; Polio #4
 - Growth and Development Assessment
 - Vision and Hearing Screening
15. 5 Years
 - Vaccines: None (unless catch up needed)
 - Growth and Development Assessment
 - Vision and Hearing Screening
16. 6-10 Years
 - Vaccines: None (unless catch up needed)
 - Growth and Development Assessment
 - Vision and Hearing Screening (even numbered years)
 - Labs: Lipid Panel at 10 years (can be earlier with risk factors)

17. 11 Years

- Vaccines: Adacel (Tdap); Menactra #1 (meningitis); Gardisil #1 (HPV vaccine)
- Growth and Development Assessment
- Depression Screening and Substance Abuse Assessment
- Labs: Lipid Panel (every 3-5 years); STI Screening (if indicated); Anemia (if indicated)

18. 12-15 Years:

- Vaccines: Complete Gardisil series (if not already completed)
- Vision and Hearing Screening (12 and 15 years old)
- Depression screening and Substance Abuse Assessment
- Labs: Lipid Panel (every 3-5 years); STI Screening (if indicated); Anemia (if indicated)

19. 16 Years - Young Adult:

- Vaccines: Menactra #2; Complete Gardisil series (if not already completed)
- Vision and Hearing Screening as needed
- Depression and Substance Abuse Assessment
- Labs: Cholesterol (standardly at 18 y/o); STI Screening (if indicated); Anemia (if indicated)
